1. Approval of the Gadsden City Board of Education's resolution regarding mill ad valorem taxes

a. Superintendent Blackwell discussed the Gadsden City Board of Education's resolution regarding mill ad valorem taxes, which will be voted on by the public on May 20, 2025. This tax is renewed every twenty years. Gadsden City Schools receives ten mills of collected property taxes. The resolution will be signed and submitted to support placing the renewal on the ballot in May. Superintendent Blackwell emphasized the importance of this tax, noting that it serves as an important funding source for Gadsden City Schools.
